- The board reviewed the 2021 budget. Audrey reminded the board that the budget is allocated until April 1 2022 and provided a review of April 1 2020 to April 1 2021 Expenses.
- Review of April 1 2021 to October 7 2021 \$15,780.50 to date expenses
- Current balance checking account \$5,150.59
- Audrey estimated expenses remaining until April 1 2022: Snow removal \$1,000
 Boulder Utility (water) \$550.00 Tree cleanup \$1,000 =\$2,550.00
 \$5,150.59 \$2,550.00 = \$2,600.59 (2021 Budget has \$2,415.00 designated for cost overrun buffer.

Audrey reminded the board that our US Bank account has a \$5,000 reserve account.

- Review of operating expenses. AG approved a 10% increase from 2021 budget and NP 2 agreed to the same increase. Audrey noted we had no budget increase for 2021 at the request of AG.
- AG April 1 2022 to April 1 2023 Dues allocation (10% increase) \$7779.48 (last year dues) :\$8556.90
- NP2 Proposed 10% increase =(last year dues) \$13,128.48 + \$1.312.80=
 \$14,441.28
- 2022 Dues Assessment \$8556.90 (AG) + \$14,441.28 (NP2) = \$22,998.18
 \$22,998.18 divided by 86 households=\$267.42 annual per household (2020 budget was \$243.12)
- Landscape Proposals: Wards and Green Spaces. The board reviewed the two
 landscape proposals from Ward's and Green Spaces and decided to approve
 Ward's. They were more inexpensive, have a good work performance record with
 CGHP HOA and irrigation repair per hour was too costly.

• Possible Projects for 2022 were reviewed:

- 1. Median 4 sod replacement: \$3,510.00 (2 areas)
- 2. Median 4 sod replacement (East end): \$1924.00
- 3. 2 Trees: \$350.00
- 4. Fertilizer \$1,407.00 (Wards)
- 5. Organo-Lawn Fertilizer: Park: \$5,295.08 Medians/Park: \$6522.95

The board approved Median 4 sod replacement (\$1,924.00), fertilizer (\$1,400) and the 2 trees (\$350.00).

Audrey shared there were no nominations for president/manager submitted. Jeff
 nominated Audrey and Evie seconded the nomination. The board unanimously
 elected Audrey to serve another year.
